## The country's biggest money launderers have been imposed on the nation

"I pay tribute to the people for the protest demonstrations held across the country, including in Punjab, Sindh and Swabi, on February 8. Even in this era of naked fascism, the people always come out in fear at my call, which proves that this nation is now waiting for real freedom in any situation. The orderly government is scared from within. Raids were carried out across the country and people were subjected to violence. We were not allowed to hold a rally at Minar Pakistan using the pretext of cricket, which clearly shows how much this hollow government is in panic from within.

I wrote the letter to the Army Chief with good intentions for the betterment of the country. This is my country and I am concerned about it. I want to tell the DG ISPR that the reputation of the army is being completely destroyed. You say that we do not interfere in politics, but every child knows that the country's system is being run by the Army Chief. The country has been imposed with touts like Mohsin Naqvi, who never contested the councilor election, but now he is in charge of everything from cricket to foreign and internal affairs.

The market for oppression and fascism is hot everywhere in the country. The funeral of the Supreme Court's autonomy was carried out through the 26th Constitutional Amendment. Qazi Faez Isa was the most biased and shameless Chief Justice in history, whose role was even more despicable than Justice Munir. During his tenure, democracy was brutally murdered, human rights were severely violated, but instead of taking any action, he facilitated every illegal action. Both the rule of law and human rights are severely violated in the country.

Their mandate was snatched from the people by creating a pretense in the name of elections. The Chief Election Commissioner and Qazi Faez Isa remained the facilitators of the establishment in all this. Both these faces betrayed their positions and the people. As a result of all this, fake MNAs, fake parliament, fake prime minister and fake president have come into existence. The work of Justice Faez Isa is now being taken over by the constitutional bench. The country has been made a republic. It is the duty of judges to hear the views of both sides, but here the decisions are given after hearing the views of only one side.

I would like to give a special message to Justice Yahya Afridi that you should stand up against the current state of human rights and law in the country and become a leader in history and not play the shameful role of a judge.

The media and social media have been strangled through the black law of PECA. The state of the internet is in front of everyone. The economy has suffered a loss of 1.7 billion dollars. Brain drain is continuing rapidly in the country. 1.7 million people have migrated abroad. The entire nation is worried about economic collapse and unemployment.

We had demanded a commission on May 9 and November 26 because we knew that the talks were just a drama. Forming a commission on February 8 was not their business. If their intentions were clear, they would have formed a commission on May 9 and November 26 and done it all because these were human rights issues and immediate action could have been taken on them, but this was not done. On November 26, the establishment opened fire and killed innocent people.

The country's biggest money launderers have been imposed on the nation. For 30 years, intelligence agencies were telling us how these two families looted the country. They showed us the files of Surrey Palace and Mayfair flats themselves. NAB was supposed to recover Rs 1100 billion. During our time, Rs 480 billion was recovered because we were serious about accountability, while in the last 17 years, only Rs 80 to 90 billion could be collected. All the cases of these two families were closed after NAB amendments were made. All the cases including Maqsood Chhapraasi, Mayfair, One Hyde Park bribery, Omni Group were closed.

We were told ourselves that these people are corrupt and now they have been imposed on us through rigging only because bootlicking is their specialty.

By giving the faces that the people of Pakistan have rejected to the government, the army has destroyed its reputation and created hatred among the people. The only way to survive this fake system is to crush the PTI and keep our people in jail so that an orderly government can remain in place and electoral fraud cannot be exposed. Conduct any survey and you will know how wide the gap between the people and the army has become.

Where there is democracy, there is progress. The example of East and West Germany is in front of everyone. There was dictatorship in East Germany and democracy in West Germany. After 50 years, everyone saw how much West Germany had progressed on the basis of democracy. The example of the Soviet Union is also in front of everyone, which was developing rapidly in the 1970s, but within 15, 20 years, due to authoritarian attitudes and policies like kidnapping in the style of the Viggos, the same conditions were created there that we have and America has gone far ahead of the Soviet Union.
